

# Moldova

## Medical Summary

*The health risk information presented here is summarized from Shoreland Travax<sup>®</sup>, a decision-support tool used by health care providers to perform a detailed health risk analysis based on specific locations, individual travel styles, and traveler risk behaviors. Travax provides practitioners current, independently researched malaria risk and prevention recommendations in a map-based format that goes beyond the annual WHO and CDC statements included here. ## General Information

Moldova is a developing nation classified as lower middle income. Located in Europe (east of Romania and west of Ukraine), the climate classifications range from dry (semi arid) to humid cold (no dry season).

## Vaccinations

Depending on your itinerary, your personal risk factors, and the length of your visit, your health care provider may offer you vaccination against hepatitis A, hepatitis B, influenza, measles, mumps, rubella, rabies, or tick-borne encephalitis. Routine immunizations, such as those that prevent tetanus/diphtheria or "childhood" diseases, should be reviewed and updated as needed.

## Other Concerns

### Travelers' Diarrhea

Moderate risk exists throughout the country, with minimal risk in deluxe accommodations. Food and beverage precautions may reduce the likelihood of illness.

Travelers should carry loperamide for self-treatment of diarrhea and, if risk is moderate to high, an antibiotic to add if diarrhea is severe. Consult a knowledgeable health care provider regarding which antibiotic is appropriate for you and most effective for your destination.

### Insect- and Arthropod-Borne Diseases

Lyme disease may pose a risk. Personal protective measures are important.

### Other Disease and Health Risks

Additional concerns include hepatitis C, tuberculosis.

## Consular Travel Advice

Due to ongoing security concerns, Canada (GAC) advises avoiding travel to Transdnistria Region. Australia (DFAT) advises reconsidering travel (or avoiding nonessential travel) to Transdnistria Region. U.S. (DOS) and U.K. (FCO) have no current warnings.

## Terrorism Risk

Risk of attack by transnational terrorist groups exists throughout Europe. Targets may include domestic and international organizations and businesses; public places and events, including those frequented by tourists; and transportation systems.

## Crime

Negligible risk of violent crime exists throughout the country. Organized criminal groups are active in casinos and nightclubs.

Moderate risk of petty crime exists throughout the country, especially in Chisinau, in crowded areas, on public transportation, and in bars and restaurants. Theft of valuables from hotel rooms is common.

Scams involving corrupt officials and false identity (such as criminals posing as police officers) have been reported.

Risk exists of robberies and/or assaults occurring after consuming intentionally drugged food or drink; tourists are frequently targeted.

## Civil Unrest

Protests and demonstrations occur throughout the country, especially in Chisinau, and have the potential to turn violent without warning. Bystanders are at risk of harm from violence or from the response by authorities. Disruption to transportation, free movement, or the ability to carry out daily activities may occur.

## Unsafe Areas

A dangerous security environment may exist in Transnistria Territorial Unit.

## Transportation Safety

National incidence data on traffic-related injury or death are not available.

Speed laws are poorly enforced.

## Natural Disasters

Seasonal flooding occurs.

Seismic activity occurs.
